## You have full control of ACH activity.

You are able to manage your ACH activity by filtering or blocking transactions and/or vendors online.

You create a disbursement file for each check. As you issue checks, you create a disbursement file with the issue date, serial number, payee and dollar amount of each check. You then securely upload the file to Greenwoods State Bank electronically through Business Online Banking.

Checks and ACH requests are electronically verified. We utilize your disbursement file to verify the checks and debits that have posted to your account. Non-matching items are reported via an Exceptions Report for your review and payment decision.

## We send you an Exceptions Report.

Your Positive Pay Exceptions Report is available to you early each morning via our online Positive Pay service through Business Online Banking. You decide about payment of each check or ACH. Simply make your pay or no-pay decisions online.

We protect you from over-thecounter fraud. We will verify checks if they are cashed over the counter at our branches, by matching these checks against your disbursement file - a feature many banks don't offer.
